Maintenance Report:

We are now at 48 smoke free units at Lakeview Manor/Annex. That is approximately 50% of our units. The unit turnaround is significantly faster and more cost effective to us as we declare each unit a smoke free unit as we rehab them. Our annual service and maintenance of our generator system will be conducted on 8/21/12 by Total Energy Systems. We had Midwest Testing conduct a water meter test of Lakeview Manor and it checked out without any deficiencies. The annual fire drill will included Quincy Haven Apartments this year and is scheduled for 10/22/2012 at 6:15 pm.

Directors Report:

Section 8 Rental Assistance program has 38 vouchers issued and there are NO vacancies at Lakeview Manor.

Finn Fest will be in the City of Hancock next year and HHC will offer the community room for a venue of an event and many Residents would like to get involved in the week long event.
