- FEMA update \$7,506,000 eligible projects, \$5,629,500 FEMA funds (75%), 12 ½ % \$938,200, State and Local match each. Requesting help from the State for local match.
- FHWA update \$3,350,689 eligible projects, FHWA funds \$2,680,551 (80%), 20% match \$670,137. Local project audits are being don on 8/15/2018.
- M-203 temporary bridge opened at the end of July.
- M-203 permanent bridge was put out for bid and Hebert construction was the low bidder on the project.
- Beach Dock construction, MJO has most of the structure done and should be substantial complete the fall.
