Updates/Information:

- Discussion regarding outstanding DDA façade grants, duration of grant, application process. Old grant
 applications remain unused and yet still dedicated by the DDA. Application for Façade Grant has no time
 limit at present and requires updating to meet new criteria.
- DIA Grant received and approved for 7 replicas from the Detroit Institute of Art. The pieces will be placed throughout the Downtown from June to October, 2020 at no expense to the City of Hancock. A \$2000 stipend was also received from the DIA for promotional and educational materials related to the project.

The Hancock Outdoor Farmers Market will be hosted from June through October on Thursdays from 3:00 to 6:00 PM. at the new location of Porvoo Park. The covered shelter will allow for spaces and other vendors are welcome to bring a tent. The goal is to revitalize the Farmers Market and increase the availability and access to fresh produce.

 The Quincy Green Condominium complex at 417 Quincy Street is moving forward and Mike Lahti is looking now at a mix of residential and commercial space in the building. The building will be modified into an ADA Compliant structure with the renovations.

City Council approved Glenn Anderson seek RFQ for engineering services related to Option A (\$3 Million)
for the Hancock Business and Technology Park Development. At present there a two companies with
significant interest and willing to write letters of intent and funding is available for Disaster Stricken
communities at 80% from the EDA.

Other Business:

Copper Country Community Arts request for a monthly stipend is received. DDA Chair Jon Luse
questioned how the funds would be used by the CCCAC and setting a precedent with other businesses.
