

SKETCH & DESCRIPTION

PARCEL 1 (Not Surveyed)

A Parcel of land located in the Northwest 1/4 of Section 27, Township 55 North, Range 34 West, City of Hancock, Houghton County, Michigan, more particularly described as follows:

Commencing at the North 1/4 Corner of Section 27, Township 55 North, Range 34 West, City of Hancock, Houghton County, Michigan: Thence S 00°25'27" W 2641.76' along the North-South 1/4 Section Line of said Section 27 to the Center of Section 27 (as monumented); thence S 89°59'07" W 16.18' along the East-West 1/4 Section Line of said Section 27; thence N 28°28'59" W (recorded as N 29°00' W) 235.14' to the POINT OF BEGINNING; thence N 28°28'59" W 238.17'; thence S 61°24'23" W 120.45'; thence along the next two (2) courses approximately 3' easterly of existing edge of asphalt drive: N 37°17'26" W 58.73' and N 27°59'30" W 294.74'; thence N 61°28'13" E (recorded as N 61°00'50" E) 156.53' along the southerly line of Houghton County Fair Association parcel; thence S 28°31'47" E 246.28'; thence S 89°28'00" E 140.46'; thence S 00°25'27" W 315.76' to the POINT OF BEGINNING.

Containing 1.83 acres of land, more or less. Subject to easements and restrictions of record, if any.

PARCEL 2 (Not Surveyed)

A Parcel of land located in the North 1/2 of Section 27, Township 55 North, Range 34 West, City of Hancock, Houghton County, Michigan, more particularly described as follows:

Commencing at the North 1/4 Corner of Section 27, Township 55 North, Range 34 West, City of Hancock, Houghton County, Michigan: Thence S 00°25'27" W 1129.17' along the North-South 1/4 Section Line of said Section 27 to the POINT OF BEGINNING; thence continuing along said North-South 1/4 Section Line S 00°25'27" W 1000.76'; thence along the North line of the Plat of the James Addition to the Clty of Hancock S 89°56'00" E 290.34'; thence S 00°24'00" E 118.56'; thence N 89°56'00" W 360.85'; thence N 00°25'27" E 1107.44'; thence N 80°16'57" E 69.90' to the POINT OF BEGINNING.

Containing 2.59 acres of land, more or less. Subject to easements and restrictions of record, if any.

PARCEL 3 (Not Surveyed)

(Per Deed as recorded in Liber 167, Page 1394, Houghton County Records)

A Parcel of land situated in the Northeast Quarter (NE1/4) of Section 27, Township 55 North, Range 34 West, City of Hancock, Houghton County, Michigan, and more fully described as follows:

Commencing at the North Quarter corner of Section 27 South along the North and South Quarter line of said Section 27 a distance of 1172.98 feet to the West edge of the DNR snowmobile trail and the Point of Beginning of the parcel to be described; thence South along the North and South quarter line of sead Section 27 a distance of 948.41 feet to the North edge of the Plat of the James Addition to the Clty of Hancock; thence South 89°56'00" East along the North edge of said Plat 330.34 feet; thence South 89°56'00" East 96.75 feet to the West edge of said DNR trail; thence North 06°21'56" West along the West edge of said DNR trail 52.98 feet; thence North 15°35'34" West along the West edge of said DNR trail 267.86 feet; thence North 25°01'01" West along the West edge of said DNR trail 248.29 feet; thence North 30°34'50" West along the West edge of said DNR trail 480.04 feet to the Point of Beginning.
