An update was given on the ROSS grant that was submitted to HUD on 3/23/2012. We received one notification for technical corrections on two items that we immediately corrected and resubmitted on 5/9/2012.

The medical Marijuana issue is still a complex issue and more information was introduced to the commission from the conference Gail attended in Lansing. There are many "gray areas" and loopholes to enforcement of the Medical Marijuana Use policy.

New Business:

The commission reviewed the 2011 Section 8 Management Assessment Program (SEMAP) scores and the 2011 PHAS (Public Housing Assessment System) scores for our Low Rent program. Section 8 finished with a 91 overall which designates us a "High Performer" where as the Low Rent program finished with a 62 designating us a "Substandard Performer". There are many concerns with the new PHAS rule and the impact it has had on what are traditionally "High Performing" PHA's. The score we received for our Low Rent program will require us to have UPCS inspections every 2 years opposed to 3 years for a standard performer. PHADA (Public Housing Authorities Directors Association) are raising substantial questions on the new rule and publicly identifying the numerous flaws in the new rule. They are calling out HUD to "Fix PHAS" and correct the new rule. Consequently many PHA's have fallen from "High Performer" status to substandard as a result.

Commission Johnson motioned to approve Resolution 01-12 Bad Debt "Tenant Write - Off Accounts". Support was made by Commissioner Givens.

After the last two rehabs we are now up to 42 units that are smoke free in Lakeview Manor and Annex.

Section 8 Rental Assistance program has 36 vouchers issued and there are 2 vacancies at Lakeview Manor.
