"AN ORDINANCE TO REPLACE ORDINANCE NO. 255 AND AMEND SECTION FOUR (4) OF ORDINANCE 123, SEWER USE MINIMUM CHARGE AND RATE AND MANDATORY CONNECTION AS AMENDED."

THE CITY OF HANCOCK ORDAINS:

Section 1. The sewer use charge for all premises shall be \$6.35 per thousand (1000) gallons of water metered. The readiness to service charge shall be \$5.00 for all premises.

Section 2. This rate increase will commence with the September, 2011 utility billing.
